IMPORTANT NOTICE

These violations/contraventions which entail that the learner may forfeit his right to hostel accommodation are also stipulated in the school's Code of Conduct. This implies that these violations can simultaneously be attended to under the school's Code of Conduct in view of expulsion from the hostel as well as from the school.

Re-application for hostel admission by persons who have forfeited their right to hostel accommodation

Expelled learners may again apply for hostel accommodation after a period of 12 months.

The applicant must be able to provide proof that during this 12-month period he has not been guilty of any misdemeanour/violation of any relevant category 2 or 3 type.

References or testimonials from institutions where he was accommodated during the period of expulsion, as well as letters of recommendation from teachers may be presented as extenuation.

The Headmaster and Housemasters may re-evaluate and update the above rules at any time if needed.
